Update from LDW & NTI: Julie showed us a few pictures from NTI on the web site. LDW not as good a presentation as expected. All NTI attendees felt they were further educated and a good time. It was felt there were less speakers available this year. The more experienced speakers were more interesting with good information relayed. November 20-Jeff Solheim/Contract: Judy had concerns with the contract wording for flight/hotel/rental car. AACN has approved this current contract. Julie spoke with him, confirming the details included. The wording in the contract for payment to the speaker, for flight etc, is mandated by national to confirm that individual chapters are responsible for the costs incurred when booking speakers, not national. The date for this educational day corresponds with the Critical Care Symposium in Portland. Discussion followed to change our date to have this speaker for this year or continue to plan for the arranged date. Consensus was to continue on, as we are, with the speaker and dates already in the works. Keeping the price as low as possible allows more people to attend and guarantees a higher turn out. Cost for this conference was discussed at \$55 for members/\$65 non-members with an early-bird special of \$5 off registration. Julie spoke about a "mini-raffle" to bring in a little more income.

The group discussed keeping an accurate calendar of our surrounding areas' usual conference dates and to try to stay on a more scheduled time/date for our educational events to avoid future conflicts.

AACN pens may be an idea to replace some of the items vendors can no longer provide at their tables/booth. Thoughts were shared to have many pen made with PCRC-AACN.
